#### III. Privilege of the Floor: James Gensel

Mr. Gensel shared an Owego Gardens II water system extension update with the board. He noted that the project is now in the construction phase. The contractor has installed the first set of pump upgrades, which is now up and running. The second of the two pumps is currently being worked on and is expected to be brought online on Monday. Robinson solicited two new bids to bring electric to the tank site. This will result in an increase in the change order for the Robinson contract.

#### VI. ED&P Update: L. Tinney

Ms. Tinney updated the board on the following items:

- ED&P worked with the Town of Nichols and Southern Tier Network to submit a USDA ReConnect III Broadband grant to bring broadband access to the unserved areas of the Town of Nichols. ARPA funds from the Town and County were leveraged as a part of the match.
- ED&P is working with Southern Tier Network on another grant application to extend broadband as far as possible up Route 38 through the towns of Newark Valley,



Berkshire, and Richford, using the balance of ARPA funds and ARC grant funds.

- The developer that was interested in building at the Lounsberry Industrial Pocket is no longer interested in doing so. Ms. Tinney has reached out to other potential developers for the site.
- Sean Lanning, the Education Workforce Coordinator with the department is looking to make business visits in the coming up weeks and setting up tours at different businesses. Ms. Tinney invited board members to attend these tours.
- The Ithaca Neighborhood Housing Services project in the Village of Owego has been stalled at the Village level.
- The TEAM Tioga breakfast is being held April 28, 2022 at Tioga Downs.

#### VII. Project Updates: L. Tinney & C. Curtis

A. Owego Gardens II

Ms. Curtis and Ms. Tinney gave additional information to the board regarding the project. Tenants are expected to move into the housing units in June. The current activities at the site include getting the pump stations up and running and tying in the existing water line to the new water line. Next week, Robinson will perform water pressure tests, then electric service to the water tank will be installed.

#### B. Lounsberry Power Study

Ms. Curtis reported that Larson Design Group is waiting on information from NYSEG in order to complete the study. Ms. Tinney is working with NYSEG to attain the needed information.

C. Prevailing Wage

Mr. Meagher advised the board that prevailing wage applies to projects that are funded by public money, including IDA money, that are valued at over \$5 million. He noted that the state has not issued regulations as to how that statue is to be interpreted. This includes determining which entity will be responsible for monitoring projects. Mr. Meagher will continue to monitor this issue and wait for guidance from New York State.

LaBella and Client hereby agree as follows:

**Description of Services:** LaBella shall perform the services set forth and described in LaBella's proposal, dated April 27, 2022, a copy of which is attached as *Exhibit A*, in accordance with the terms and conditions of this contract attached as *Exhibit B*.

**Compensation for Services:** A retainer in the amount of \$100,000 shall be required prior to the initiation of services. This retainer will be held until the end of the Project and applied to Client's final invoice. Any excess amount shall be returned to Client. Client shall compensate LaBella for its professional services as set forth in LaBella's proposal. LaBella shall submit invoices for services rendered monthly. Client shall make payment to LaBella no later than thirty (30) days after the date of each invoice.

**Term:** LaBella shall commence performing its services when Client gives notice to proceed. This Agreement shall terminate when LaBella's services are completed and final payment has been received from Client, or as otherwise provided in this Agreement.

- Comprehensive general liability insurance with policy limits of not less than \$1,000,000 each occurrence and \$2,000,000 in the aggregate for bodily injury and property damage;
- Automobile liability insurance covering owned, non-owned, rented and hired vehicles operated by LaBella with policy limits of not less than \$1,000,000 combined single limit and aggregate for bodily injury and property damage;
- Umbrella liability insurance with policy limits of not less than \$10,000,000 each occurrence and \$10,000,000 in the aggregate;
- Worker's compensation insurance at statutory limits and employer's liability insurance with a policy limit of not less than \$1,000,000 for all employees engaged in the rendering of professional services under this Agreement; and
- Professional liability insurance with policy limits of not less than \$5,000,000 per claim and \$7,500,000 in the aggregate.

Client shall be named as an additional insured on a primary and non-contributory basis under the CGL, Automobile and Umbrella insurance policies. LaBella shall provide to the Client certificates of insurance evidencing compliance with the requirements of this Agreement. LaBella Associates, D.P.C. (LaBella) is pleased to submit the following proposal to provide Tioga County Industrial Development Agency with Professional Consulting Services relating to Asbestos-Containing Materials (ACM) Inspection and Testing services associated with the two barns and three silos located at the intersection of Stanton Hills Road and Buck Road in Nichols, New York. This proposal outlines our understanding of the scope of services and fee.

#### SCOPE OF SERVICES

The project objective is to identify a variety of suspect ACMs that may require removal or abatement prior to demolition/renovation projects. It is our understanding that the interior, exterior, and roofing system of the two barns and three silos will be the primary focus of this inspection.

#### Inspection Procedures:

Asbestos (building related)

- LaBella's Field Inspector will complete a thorough evaluation of the interior, exterior and roofing system of the structures for the presence of suspect ACMs. All suspect ACMs will be sampled in accordance with AHERA regulations, 40 CFR Part 763.86 and 763.87 and NYS Code Rule 56, thereby strictly defining the proper discrimination of homogeneous materials and the required number of samples to establish the absence of asbestos. Destructive sampling techniques will be employed during this inspection.
- Loose vermiculite fill is a common insulator used in walls of CMU construction. A limited number of small holes will be drilled into select CMU walls (if applicable) to check for the presence of vermiculite insulation.
- All suspect ACM samples will be submitted for laboratory analysis. Samples will undergo Polarized Light Microscopy (PLM) analysis to determine the presence of asbestos. As required by New York State Department of Health, samples of materials that contain a matrix that interferes with PLM analysis, and that are inconclusive by PLM analysis, will then be analyzed by Transmission Electron Microscopy (TEM).
- An estimate of the number of required bulk samples has been prepared without detailed knowledge of the structures. The final number of samples requiring analysis is determined by the number of homogenous building materials identified in accordance with NYS Code Rule 56 and may therefore vary from the estimate provided.

- Collect and record site data sufficient to report approximate locations, condition, and quantities of confirmed ACM(s). These quantities will be presented in the Inspection Report and may be used to help generate budget estimates. It is recommended that an abatement design be completed prior to soliciting for any required asbestos abatement services.
- New York State regulation requires that the presence of confirmed damaged ACM(s) be considered an Incidental Disturbance with specific response requirements. The presence of damaged ACM(s) and the need for an assessment of Incidental Damage is unknown. Therefore, no fee or fee contingency has been included in this proposal to cover the response to the discovery of Incidental Damage.

#### Report:

A final report will be prepared for the project. The report will list confirmed ACM(s) by homogeneous area, describe locations, condition, and provide approximate quantities. Sample location drawings will be prepared to record the samples locations. Drawings will not be to scale.

#### **PROJECT CONDITIONS**

The following conditions are anticipated during the completion of the building survey portion of the project:

- Collection of bulk samples of suspect ACMs will be limited to those materials safely and readily accessible throughout the structures. That is, confined or unsafe spaces will not be inspected. However, the inspection will be completed in such a way to access as much of the building spaces as possible.
  - The presence of such spaces and the need for destructive investigation will be documented in the final reports. No attempt will be made to observe conditions in spaces not generally accessible, including but not limited to crawlspaces, pipe chases, plenums, or confined spaces.
- The owner or an owner's representative will provide access to all areas of the subject structures on the scheduled day of inspection. The costs associated with additional unplanned trips to the site to inspect previously unavailable spaces is extra and will be charged using the unit rates provided below.
- Testing of accessible roofing is included in this scope of work. Roof sampling can compromise the integrity of roofing systems. As required, roof sampling resulting in roof penetrations will be repaired. LaBella will patch asphalt roof systems at sample penetrations using trowel-grade, non-asbestos roofing cement.
- Representative samples of suspect materials will be collected in the quantities and locations as determined by the certified inspector in a manner consistent with recognized professional practices. Results of analysis of the samples collected will be used to draw general conclusions, concerning the approximate locations and quantities of materials present at the site.

#### DATA GAPS AND SIGNIFICANT ASSUMPTIONS

During the preparation of this inspection report, LaBella may make various assumptions due to the inaccessibility, or unavailability and lack of receipt of information in order to complete the Scope of Work. These Assumptions will be specified and reported in the "Data Gaps" and "Significant Assumption" sections of the inspection report. The parties hereby waive any objection which they may have now or hereafter to the venue of any such suit, action or proceeding, and hereby irrevocably consent to the personal jurisdiction of any such court in any such suit, action or proceeding.

**Choice of Law:** This Agreement shall be interpreted, construed and enforced in accordance with the laws of the state where the project is located without giving effect or reference to any conflict of laws provisions.

**Consequential Damages:** In any suit, action or proceeding, the parties shall be entitled to recover compensatory damages incurred as a result of the breach of this Agreement, but, to the fullest extent permitted by law, neither party shall be liable to the other for any special, incidental, indirect, or consequential damages.

Late Fees, Costs and Attorneys' Fees: An additional charge of 1.5% of an invoice will be imposed each month on all past due accounts. - b. Analysis of all "non-NOB" materials shall be performed by Polarized Light Microscopy (PLM) following the EPA 600/M4-82-020 and the NYSDOH ELAP 198.1 methodologies.
- c. Analysis of all NOB samples shall initially be performed by NYSDOH ELAP 198.6 PLM methodology. If all samples from a given sample set are reported as non-asbestos by 198.6, samples will then be analyzed by NYSDOH ELAP 198.4 TEM methodology.
- d. In accepting reports of observations, tests, photographs, and opinions provided pursuant to this AGREEMENT, CLIENT acknowledges that the extent of TESTING AGENCY's obligation with respect thereto is limited to furnishing of such data, which shall not be solely used by others to determine acceptance of any construction work, nor shall it relieve the contractor in any way from his obligations and responsibilities to conduct the work in conformance with the project plans and specifications.

### PAYMENT AND TERMINATION

#### **Payment Due**

Invoices shall be submitted by the TESTING AGENCY are due upon presentation and shall be considered past due if not paid within thirty (30) calendar days of the invoice date.

#### Interest

If payment in full is not received by the TESTING AGENCY within thirty (30) calendar days of the invoice date, invoices shall bear interest at one-and-one-half (1.5) percent (or the maximum rate allowable by law, whichever is less) of the PAST DUE amount per month, which shall be calculated from the invoice due date. Payment thereafter shall first be applied to accrued interest and then to the unpaid principal.

#### **Collection Costs**

#### **Suspension of Services**

If the CLIENT fails to make payments when due or otherwise is in breach of this Agreement, the TESTING AGENCY may suspend performance of services upon seven (7) calendar days' written notice to the CLIENT. The TESTING AGENCY shall have no liability whatsoever to the CLIENT for any costs or damages as a result of such suspension caused by any breach of this Agreement by the CLIENT. Upon payment in full by the CLIENT, the TESTING AGENCY shall resume services under this Agreement, and the time schedule and compensation shall be equitably adjusted to compensate for the period of suspension plus any other reasonable time and expense necessary for the TESTING AGENCY to resume performance.

#### Termination of Services

This Agreement may be terminated by either party upon not less than seven (7) days' written notice should the other party fail substantially to perform in accordance with the terms of this agreement through no fault of the party initiating the termination.

This Agreement may be terminated by the CLIENT upon not less than seven (7) days' written notice to the TESTING AGENCY for the CLIENT's convenience and without cause.

If the CLIENT fails to make payment to the TESTING AGENCY in accordance with the payment terms herein, this shall constitute a material breach of this Agreement and shall be cause for termination of this Agreement by the TESTING AGENCY.

#### Set-offs, Backcharges, Discounts

Payment of invoices shall not be subject to any discounts or setoffs by the CLIENT, unless agreed to in writing by the TESTING AGENCY. Payment to the TESTING AGENCY for the services rendered and expenses incurred shall be due and payable regardless of any subsequent suspension or termination of this Agreement by either party.

#### Satisfaction with Services

Payment of any invoice by the CLIENT to the TESTING AGENCY shall be taken to mean that the CLIENT is satisfied with the TESTING AGENCY's services to the date of payment and is not aware of any deficiencies in those services.

#### **Disputed Invoices**

If the CLIENT objects to any portion of an invoice, the CLIENT shall so notify the TESTING AGENCY in writing within seven (7) calendar days of receipt of the invoice. If such matter relates to or is the subject of a lien arising out of the TESTING AGENCY's services, the TESTING AGENCY may proceed in accordance with applicable law to comply with the lien notice or filing deadlines prior to the resolution of the matter. Interest as stated above shall be paid by the CLIENT on all disputed invoice amounts that are subsequently resolved in the TESTING AGENCY's favor and shall be calculated on the unpaid balance from the due date of the invoice.

To the fullest extent permitted by law, total liability to CLIENT for any and all injuries, claims, losses, expenses, or damages whatsoever arising out of or in any way related to the project or this Agreement from any cause or causes included but not limited to TESTING AGENCY's negligence, errors, omissions, strict liability, breach of contract, or breach of warranty shall not exceed the total reimbursement received by TESTING AGENCY from CLIENT on this Project or five thousand dollars (\$5,000), whichever is less. TESTING AGENCY will be responsible only for the instruments of service furnished by it but shall not be responsible for the interpretation and/or misuse by others of the information developed. CLIENT agrees to indemnify and hold TESTING AGENCY harmless from and against all claims, damages, losses, and expenses arising from the interpretation and/or misuse by others of instruments of service provided by TESTING AGENCY.

#### **Consequential Damages**

Notwithstanding any other provision of this Agreement, and to the fullest extent permitted by law, neither the CLIENT nor the TESTING AGENCY, their respective officers, directors, partners, employees, contractors, or professional associates shall be liable to the other or shall make any claim for any incidental, indirect, or consequential damages arising out of or connected in any way to the Project or to this Agreement. This mutual waiver of consequential damages shall include, but is not limited to, loss of use, loss of profit, loss of business, loss of income, loss of reputation, or any other consequential damages that either party may have incurred from any cause or action including negligence, strict liability, breach of contract, and breach of strict or implied warranty. Both the CLIENT and the TESTING AGENCY shall require similar waivers of consequential damages protecting all the entities or persons named herein in all contracts and subcontracts with others involved in this project.

#### **Third Party Beneficiaries**

Nothing contained in this Agreement shall create a contractual relationship with or a cause of action in favor of a third party against either the CLIENT of the TESTING AGENCY. The TESTING AGENCY's services under this Agreement are being performed solely for the CLEINT's benefit, and no other party or entity shall have any claim against the TESTING AGENCY because of this Agreement or the performance or nonperformance of services hereunder. The CLIENT and the TESTING AGENCY agree to require a similar provision in all contracts with contractors, subcontractors, professional associates, vendors, and other entities involved in this Project to carry out intent of this provision.

#### Information Provided by Others

The CLIENT shall furnish, at the CLIENT's expense, copies of the project plans and specifications prior to project initiation. The TESTING AGENCY may use the above information in performing its services and is entitled to rely upon the accuracy and completeness thereof.



# III. Scope of Services



Audit engagements are staffed at the proper level of experience in relation to the complexity of the client engagement and experience in the client's industry.

Our audit approach places heavy emphasis on thorough planning and client involvement to ensure the timely identification of key business and accounting issues and resulting audit strategies.



**Service Delivery Model:** The audit process involves planning an overall audit strategy for the expected conduct, organization, and staffing of the audit. Although many planning activities are performed prior to the commencement of fieldwork, planning is not a discrete phase of the audit – rather, it is an iterative process that begins with engagement acceptance and continues throughout the audit.

Our communication with management takes place during every phase of the audit. As part of our two-way communication with management, we will convey an overview of the planned scope and timing of the audit. At the conclusion of the audit, we will communicate our audit findings. We begin the audit process by meeting with management to clearly identify needs and expectations, including inquiries about risks, concerns, and changes in the organization.

Step 1 – Understanding the Client: We must first obtain a broad and deep understanding of the nature of the TCIDA in order to understand the account balances, classes of transactions, key systems, and disclosures relevant to its activities. Our understanding also encompasses relevant industry and other external factors. We seek to understand the TCIDA objectives and strategies, along with the related business risks that may result in material misstatement of the financial statements. We gain an understanding of the policies and procedures that the TCIDA uses to measure and review financial performance in order to better understand how management monitors these risks.

We consider whether the TCIDA selection and application of accounting policies are appropriate and consistent with generally accepted accounting principles. We obtain an understanding of the TCIDA policies for presentation and disclosure in the financial statements. Much of our effort to understand the TCIDA will focus on obtaining an understanding of internal control that is sufficient to assess the risks of material misstatement and design the nature, timing, and extent of audit procedures.

Step 2 – Risk Assessment: We use the knowledge and understanding we have gathered, together with other factors, to first assess the risk that errors or fraud may cause a material misstatement of the financial statements. We then decide whether the identified risks of material misstatement pertain to specific relevant assertions related to significant account balances, classes of transactions, or disclosures, or whether they relate to the financial statements taken as a whole, which could potentially affect many relevant assertions. We then determine which of the identified risks of material misstatement are significant risks that require special audit consideration. Our risk assessment process at the account balance or class of transactions level consists of:

- A an assessment of inherent risk (the susceptibility of an assertion relating to an account balance or class of transactions to a material misstatement, assuming there are no related controls), and
- A an evaluation of the design effectiveness of internal control over financial reporting and our assessment of control risk (the risk that a material misstatement could occur in an assertion and not be prevented or detected on a timely basis by the TCIDA internal controls).

**Step 3 – Further Audit Procedures:** We then determine the nature, timing, and extent of tests of controls and substantive procedures necessary given the risks identified and the controls as we understand them. When audit evidence from further audit procedures contradicts the audit evidence from risk assessment procedures upon which we based the planned further audit procedures, we will revise the assessment and plan and perform additional or different audit procedures to reduce the risk of material misstatement related to those assertions to an acceptable level.

Step 4 – Evaluation: At the conclusion of the audit, we evaluate the sufficiency and appropriateness of the audit evidence obtained and whether the assessments of the risks of material misstatement at the relevant assertion level remain appropriate. We may re-design planned audit procedures based on our evaluation. We also evaluate the effects, both individually and in the aggregate, of known and likely misstatements that are not corrected by the Agency. We will accumulate all known and likely non-trivial misstatements identified during the audit and communicate them to management on a timely basis.

Step 5 – Delivery: We will communicate with you frequently throughout the audit process to avoid surprises at the end. Our audit will culminate with the issuance of our report on the financial statements, our report to management, and our communications of material weaknesses and significant deficiencies (if any). All matters identified in the audit process will be discussed with management as part of our ongoing meetings throughout the audit process to ensure that there is agreement as to the facts and to provide management with the opportunity to comment before any comments are formally completed for presentation to the Agency's Board of Directors.

### Internal Controls Structures and our Risk Assessment Approach

Internal control is a process, affected by management and other personnel, designed to provide reasonable assurance of achieving objectives. Our assessment of internal control is concentrated in the following areas:

- Inquiries of appropriate entity personnel regarding the design and/or application of a relevant internal control policy or procedure including the classes of transactions to which the policy or procedure applies, how it is applied and by whom, and the disposition of exceptions detected by the policy or procedures.
- Inspection of documents and/or reports evidencing the design and/or application of the relevant policy or procedure by the Agency's personnel, noting how the policy or procedure is applied and by whom, the classes of transactions to which it applies, and the disposition of exceptions detected by the policy or procedure.
- Observation by the auditor of the performance of the relevant policy or procedure by Agency personnel, noting how the policy or procedure is applied and by whom, the classes of transactions to which it applies, and the disposition of exceptions detected by the policy or procedure.
- Re-performing the application of the policy or procedure by the auditor and comparison between the results obtained by the auditor and those obtained by Agency personnel.

Our audit approach is based on our gaining a thorough understanding of your internal control systems. Our approach will go beyond completing checklists and forms.
